

## Dear Four Winds Members,

Let us start by saying "thank-you" to all the members for their patience during this pandemic. We have had to make many decisions quickly to ensure everyone remains healthy. Not all decisions were accepted easily by everyone, but we did and still do have everyone's best interest in mind.

Safer at Home: Phase Three takes effect July 1, 2020. The primary direction provided in the guidelines emphasizes, "...maintaining appropriate physical distance between persons not living in the same household..., limit the occupancy of physical spaces to ensure that adequate physical distancing may be maintained... and practice routine cleaning and disinfection of high contact areas..." Though the restrictions are greatly eased, there are still restrictions that we will be required to continue to enforce.

- The Out of Bounds will remain open but continue to have limited hours. This is based on membership cooperation and our examination of return on investment (ROI) data. Guidance for customer space limitation has changed and will be adjusted accordingly.
- The large pool and diving area will open on June 26. The baby pool will remain closed. Pool hours and rules and regulations, based on Phase Three guidance, are attached.
- The Youth Center will remain closed until disinfecting requirements are established and put in place. Concession stand will remain closed until full inspection by health department.
- Overnight guests can resume visitation. Please be cautious of the number of visitors.
- Social gatherings are still restricted to 50% occupancy of the event space.
- All outside workers requiring entry must continue to be pre-approved and coordinated with the Office and Security. Additionally, the requesting Member will continue to meet their party at the gate to escort them on and off the property.
- Employees working in customer-facing areas are required to wear face coverings over their nose and mouth.

We will continue to adjust Four Winds restrictions as directed by Virginia and Caroline County guidelines and laws. Again, thanks to everyone for doing his or her part as we try to get back to some resemblance of "normal". Further information regarding Covid-19 actions will continue to be distributed as received.

## **POOL GUIDELINES**

EFFECTIVE: 26 June 2020

## **Pool Hours: Friday thru Sunday (until further notice)**

- 11:00am to 2:00pm Open for Swimming
- 2:00pm 3:00pm Closed for Disinfecting and Sanitization
- 3:00pm to 7:00pm Open for Swimming
- 7:00pm Closed for final Disinfecting and Sanitization

The following rules and regulations apply:

**DECK SEATING**: Limited to 35 people based on 10 ft. distance requirement.

MAIN POOL: Open swim with social distancing **DIVING AREA**: Open swim with social distancing

**BABY POOL and SLIDE: Closed** 

## PER The Four Winds Club Inc. Rules and Regulations (8 June 2019):

**SWIM AT YOUR OWN RISK** A swim at your own risk is in effect at the Four Winds lake, river and swimming pool. Children ages 12 and under should not use the pool, enter the lake or river without adult supervision (age 18 or over). Swimmers understand that they are responsible for their own safety.

<u>CHILDREN UNDER THE AGE OF EIGHT (8)</u> A responsible adult must accompany all children at and under the age of eight (8) anytime they are not on their own lot/campsite. This is to include public facilities, restrooms, swimming pool, playground and youth center.

No food or drink is allowed IN the pool. No glass or breakable containers are allowed in the Deck Seating area,

SMOKING AND VAPING are prohibited in the pool area. NO ALCOHOL is permitted in or around the youth center, pool and playground areas. These areas are alcohol/drug free zones.

# PER By-Laws of The Four Winds Club Inc. (14 September 1986): Suspension of Membership Rights.

Default in Payments. During any period in which a Member shall be in default in a payment of any annual dues, charge or assessment levied by the Club, voting rights, and the right to use the facilities and other improvements of the common areas by a Member, his designees or guests may be suspended by the Board of Directors until such dues, charge or assessment has been paid along with all penalties and interest levied thereon.

#### All members, guests and employees are expected to abide by COVID-19 rules.

- Do not enter with symptoms of Fever, Cough or Shortness of Breath
- Wear a mask while out of pool/in deck seating
- Exercise social distancing (10 ft. minimum while out of pool)
- Do not share goggles or other swim equipment
- Children who are too small to maintain social distance should not be at the pool

THE ONLY EXCEPTION TO THESE RULES IS EMERGENCY EVACUATION OR THE RESCUE/ADMINISTRATION OF FIRST AID OR CPR TO A SWIMMER IN DISTRESS
